You have been selected as a prospective juror for Churchill County for the year 2013. Please complete and return the questionnaire in the envelope provided. If your name is drawn during the coming year, you will receive a summons to appear approximately 10 days prior to the date you are required to be present for the Jury Selection process. The Jury Commissioner's Office is located in the Law Enforcement Facility on the Second Floor. The right of a trial by jury is the privilege of every person in the United States. This right is guaranteed by the U.S. Constitution and the Constitution of the State of Nevada, which states "the right of trial by Jury shall be secured to all and remain inviolate forever." We thank you for supporting jury service and hope you find the experience both interesting and rewarding.

IMPORTANT

If you are not a U.S. citizen, or are a convicted felon without your civil rights restored, you are not eligible to serve on a jury. Please check the appropriate box on the reverse side of this form, sign and return.

YOU MUST ANSWER the felony question below and the citizen question on the reverse side of this form. We must know if you are a convicted felon or are not a citizen.

FAILURE TO RESPOND

Per NRS 6.040, the penalty for failure to appear for jury service may result in a contempt of court charge and a fine of not more than \$500.00.

QUALIFICATIONS

Per NRS 6.010: "Every qualified elector of the state whether registered or not who has sufficient knowledge of the English language, and who has not been convicted of treason, felony or other infamous crime, and is not rendered incapable by reason of physical or mental infirmity, is a qualified juror of the county in which he resides." Sign and return if you are not a U.S. citizen.

AGE EXEMPTION

If you are 70 years of age or older, you do not have to serve.

TERM OF SERVICE

Jurors are required to telephone a prerecorded message to obtain reporting information. If not required to report on their first assigned date, they are rescheduled.

DRESS CODE

Juror attire should reflect the dignity and professionalism of the Court. Please refrain from wearing shorts, tank tops, sweat pants, sweat shirts or t-shirts with offensive statements. The temperature of the courtrooms may fluctuate. Jurors are encouraged to dress accordingly.

JUROR FEES

Selected: \$40 per day.
Selected jurors will be paid by check within 2 - 3 weeks of jury service.
